
As approved by the Academic Council and Board of Management in its meetings held on 9.2.2022 and 30.3.2022 respectively, it is notified for the information of all the concerned that the Policy for Life Long Learnig Access is prepared as under and shall be implemented with immediate effect.

Life Long learning Access Policy

INTRODUCTION: Datta Meghe Institute of Medical Sciences (Deemed to be University) was granted the status of Deemed to be University by University Grants Commission, on 24th May, 2005. Immediately after getting the Deemed to be University status, the DMIMS (DU) has opted for inspection by National Assessment & Accreditation Council, and accordingly Peer Team from NAAC inspected the DMIMS (DU) campus and its constituent units and accredited the DMIMS (Deemed to be University) with 'A' Grade, in March 2007. Thereafter, Datta Meghe Institute of Medical Sciences (Deemed to be University) was conferred 'A' Grade status by the Ministry of HRD, Government of India amongst the Deemed Universities in the Country, in the month of May 2013.

It has been reaccredited with the 'Grade A' by the National Assessment and Accreditation Council (NAAC) for a period of five years, in March 2013. Thereafter, in the 3rd cycle of reaccreditation by the NAAC, the University has been re-accredited with "A+" Grade making it a unique Health Sciences University in the County to have such a unique distinction, in the 3rd cycle of its re-accreditation, in the year 2017. Subsequently, it was placed in 'Category-I Deemed to be University' as per University Grants Commission (Categorisation of Universities only) for grant of graded autonomy, regulations 2018. It has also been included in the list of Deemed to be Universities under 12 B of UGC Act, 1956. The University is also received the prestigious Dr. B.C. Roy Award for Institutional Research.

OBJECTIVE: Any not for Profit, Institution is established for the purpose of engaging and participating in the welfare of all its stake holders. The DMIMS is established as an Not-for-Profit entity with the noble thoughts from the Founders for the purpose establishing inter alia Free Medical Care to the local community especially for the less privileged and marginalized.





<u>CONTINUING EDUCATION TO STAFF</u>: Continuing Education to staff of the DMIMS in the ever changing Technology Era, is done to Lifelong Learning and Educational Access Program which provides every opportunity to involve in continuous improvement and development of skills not just to perform their jobs but also to their families and helpful to the Community at Large.

<u>**CONTINUING EDUCATION TO FACULTY</u>**: This lifelong Learning Policy of DMIMS is also focus on the faculty who are highly Qualified and renowned Professional known for their expertise in their domain of health care. Equal importance is given to their upgrading to the requirements of growing demands in different areas and technology by incentivizing them with various supports financially and also through sanction of Sabbatical and Research support with paid holidays for enrichment of their expertise and professional qualifications. Faculty are encouraged to attend Regional / National / International Conferences, apart from attending and conducting various Faculty Development Programs (FDPs) within and outside Institute, India and abroad.</u>
