6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

"The Postgraduate Committee considered the assessment report (08.04.2014) and decided to recommend that MD(Psychiatry) qualification against increased intake from 01(One) to 02(Two) seats granted by Datta Meghe Institute of Medical Sciences (Deemed University), Wardha in respect of students being trained at J. N. Medical College, Swangi, Wardha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.
