Applications are invited from eligible candidates for the **DMIHER-CET-2025**. DMIHER-CET-2025 shall be conducted for admission to the **Bachelor of Physiotherapy (B.P.T.)** program for the academic session 2025-26.

Eligibility:

- The candidate should be an Indian National and should have passed the Higher Secondary School Certificate (10+2) Examination of Maharashtra State Board or from CBSE board or ICSE board or its equivalent examination with subjects English, Physics, Chemistry, and Biology. The Candidate should have completed 17 years of age on or before 31/12/2025. The candidate should have passed Higher Secondary (10+2) Examination of Maharashtra State Board of Secondary and Higher Secondary Education or any other recognized Higher Education Board in India.
- Candidates who are appearing in 12th Science State Board / CBSE/ ICSE or any equivalent examination in the year 2025 are eligible to apply.

- Pattern of examination: **100 MCQs of Physics, Chemistry, and Biology with no negative marking.**
- Distribution of Questions:

Subject	No. of questions	Marks
Biology (Botany)	25	25
Biology (Zoology)	25	25
Chemistry	25	25
Physics	25	25
Total Questions	100	100

- Admission schedule and counseling dates shall be communicated separately to the eligible candidates.
- The admissions shall be done on the basis of the inter-se-merit of marks obtained in the DMIHER-CET-2025, strictly on the basis of merit.
- The candidates with a non-zero score in DMIHER-CET-2025 will be eligible for admission.
- Rules of Tiebreaker – In case of two candidates having similar marks in DMIHER-CET-2025, the following tiebreaker criteria shall be followed:
 - The one who has higher marks in PCB group of HSC examination shall be preferred.
 - If the tie still persists, then candidate with higher marks in Biology in 12th standard shall be preferred.
 - If the tie still persists, the candidate with higher marks in Chemistry in 12th standard shall be preferred over the younger candidate.
 - If tie still persists, a candidate with higher percentage of aggregate marks at SSC shall be preferred
 - If tie persists, an older candidate shall be preferred over a younger candidate.

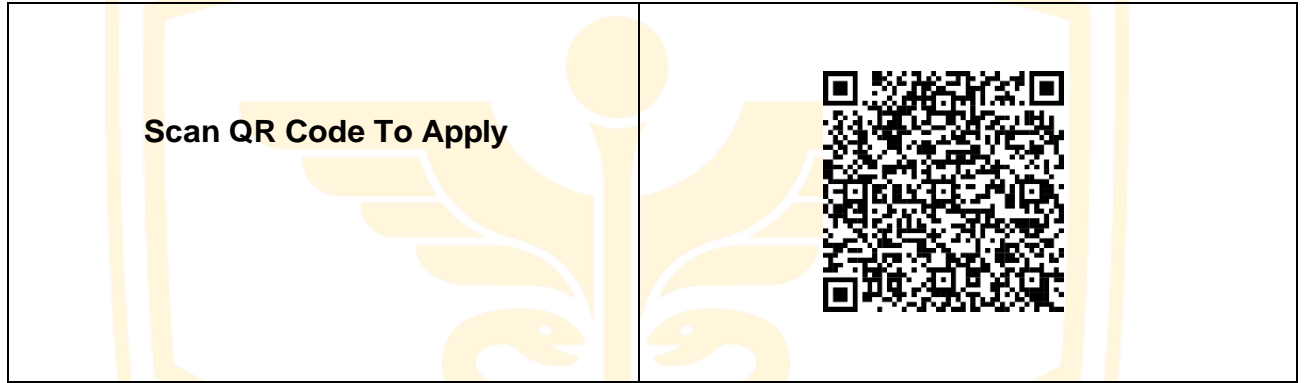
