BCA (Bachelor of Computer Application)	3 Years	The candidate should have passed Higher Secondary (10+2) OR Equivalent Examination recognized by any Indian University with minimum 45% Marks (40% for Reserved Categories) in any Qualifying Examination. AND Qualifying DMIHER CET-2025 / MAH-BCA CET-2025 (with Non-Zero Score)

- Candidates who are appearing in 12th any stream State Board / CBSE/ ICSE or any equivalent examination in the year 2025 are eligible to apply for BBA.
- Candidates who are appearing in 12th Science State Board / CBSE/ ICSE or any equivalent examination in the year 2025 are eligible to apply for BCA.

Syllabus of DMIHER-CET-2025-BBA/BCA:

1. Logical / Abstract Reasoning

There will be questions to gauge your capacity for quick and accurate thought. Both verbal reasoning questions and questions based on figures and diagrams may be present in this test.

2. Quantitative Aptitude

This will involve answering questions regarding your ability to work with numbers quickly and accurately, perform mathematical calculations, and comprehend a variety of arithmetic problems involving ratios and proportions, percentages, etc. The ability to interpret tables, standard graphs, and charts, as well as your capacity for quantitative reasoning, are also assessed through this test.

3. Verbal Ability and Reading Comprehension

This will include passages that have comprehension-testing questions based on their content. Questions on grammar, vocabulary, sentence completion, synonyms, antonyms, passage comprehension, etc. will be used to assess your English language proficiency. Your command of the English language will be evaluated.

Pattern of examination:

1. Pattern of examination: 100 MCQ's comprising questions of Verbal Ability and Reading Comprehension, Reasoning, and Quantitative Aptitude.
