Applications are invited from the eligible candidates for admission to MBA/MCA courses under the School of Allied Sciences for the academic session 2025-26 through the DMIHER-CET-2025-MBA/MCA.

Eligibility:

- 1. Eligibility for MBA Program:** Candidate must have passed a degree of minimum 3 years duration. Obtained at least 50% marks (45% marks in case of candidates belonging to reserved category) in the Qualifying examination. AND/OR Qualifying DMIHER-CET-2025-MBA/MCA, MAH-CET-2025/CAT2024/CMAT-2025/MAT2025 (with Non-Zero Score)/ any National or State Level Management Entrance examination in the year 2025. The candidates who have completed graduation or are appearing in their final year are eligible to apply.
- 2. Eligibility for MCA Program:** Passed BCA/ Bachelor Degree in Computer Science Engineering or equivalent Degree OR Passed B.Sc./ B.Com./ B.A. with Mathematics at 10+2 Level or at Graduation Level (with additional bridge Courses as per the norms of the University) Obtained at least 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination AND/OR Qualifying DMIHER-CET-2025-MBA/MCA, MAH-MCA-CET- 2025/ NIMCET2025 (with Non-Zero Score)/ National or State Level Management Entrance examination in the year 2025. The candidates who have completed graduation or are appearing in their final year are eligible to apply.
- 3. Eligibility for MBA (Lateral Entry):** Passed B. E. or B. Tech or BBA or BMS (4 Years)

Syllabus of DMIHER-CET-2025-MBA/MCA/MBA Lateral:

1. Logical / Abstract Reasoning

There will be questions to gauge your capacity for quick and accurate thought. Both verbal reasoning questions and questions based on figures and diagrams may be present in this test.

2. Quantitative Aptitude

This will involve answering questions regarding your ability to work with numbers quickly and accurately, perform mathematical calculations, and comprehend a variety of arithmetic problems involving ratios and proportions, percentages, etc. The ability to interpret tables, standard graphs, and charts, as well as your capacity for quantitative reasoning, are also assessed through this test.

3. Verbal Ability and Reading Comprehension

This will include passages that have comprehension-testing questions based on their content. Questions on grammar, vocabulary, sentence completion, synonyms, antonyms, passage comprehension, etc. will be used to assess your English language proficiency. Your command of the English language will be evaluated.

Pattern of examination:

1. Pattern of examination: 100 MCQ's comprising questions of Verbal Ability and Reading Comprehension, Reasoning, and Quantitative Aptitude.
2. Distribution of Questions:

Two marks per correct answer. No negative marking.

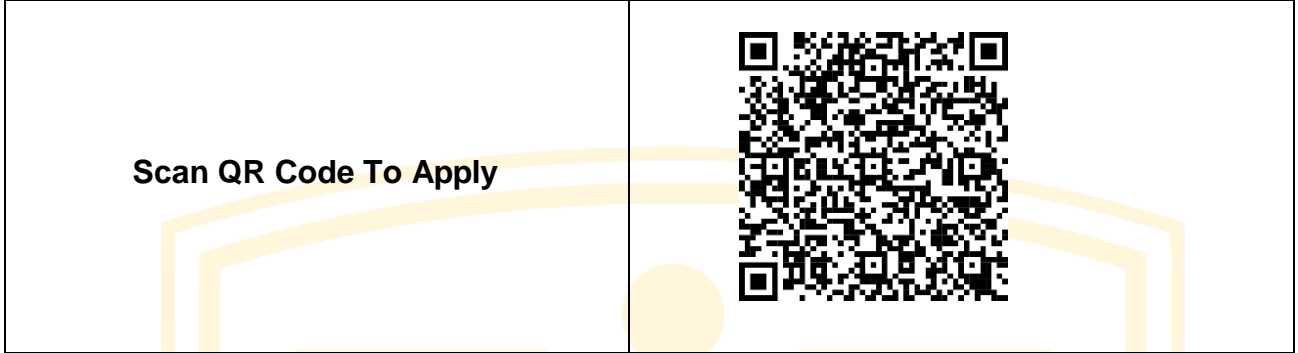
