Applications are invited from the eligible candidates for admission to Undergraduate programs under the School of Allied Health Sciences (**Wardha Campus**), DMIHER (DU), for the academic session 2025-26. **DMIHER-CET-2025** shall be conducted for the admissions to Undergraduate Course Programs for the academic session 2025-26.

Eligibility:

Candidates, seeking admission to the Under Graduate Degree Bachelor of Sciences in the Faculty of Allied Health Science under University shall have passed (10+2) from a recognized university in any discipline. examination recognized as equivalent thereto;

OR

Has passed an examination equivalent to the Higher Secondary School Certificate (HSSC) of any recognized Board / University situated in India;

OR

Has passed Central Board of Secondary Education (CBSE) Examination;

OR

Has passed an Indian School Certificate (ISC) Examination;

OR

Has passed examination from any School / College situated abroad, as equivalent thereto shall submit equivalence certificate from the Association of Indian Universities, New Delhi.

AND

Minimum 50% aggregate marks or 45% in case of candidates covered under disability act and 40 % for candidate belonging to reserved category

- Admission schedule and counseling dates shall be communicated separately to the eligible candidates.
- The admissions shall be done on the basis of the inter-se-merit of marks obtained in the DMIHER-CET-2025, strictly on the basis of merit.
- The candidates with a non-zero score in the DMIHER-CET-2025 will be eligible for admission.
- Rules of Tiebreaker – In case of two candidates having similar marks in DMIHER-CET-2025, the following tiebreaker criteria shall be followed:
 - The one who has higher marks in PCB/PCM (whichever is higher) group of HSC examination shall be preferred.
 - If the tie still persists, then aggregate marks of HSC shall be considered and the candidate having higher aggregate marks shall be preferred.
 - If the tie still persists, the older candidate shall be preferred over the younger candidate.
